Declaration of Applicant

I understand that I must abide by the Rules and By-laws of the Club and I must obey the lawful and reasonable directives of the Captain, Vice-Captains and Committee of Management as provided by the Rules.

I, the undersigned, as a condition of acceptance of my membership of Balmain Rowing Club, for myself, my heirs, executors and administrators, hereby waive all and any claim, right or cause of action which they or I might otherwise have arising out of loss of my life or injury, damage or loss of any description whatsoever which I may suffer or sustain in the course of or consequent upon my membership of Balmain Rowing Club or participation in any activity resulting from said membership. I also realise that to compete I must be a registered member of Rowing New South Wales Association and FISA and must comply with the definition of an amateur as set down by Rowing New South Wales Association and FISA.
